

## BACKGROUND

### Study on the Creation of a Marine Protected Area in Îles-de-la-Madeleine

#### Mandate and Membership of the Advisory Committee

On December 5, 2011, the governments of Canada and Quebec announced an agreement to conduct a study on the creation of a marine protected area in Îles-de-la-Madeleine. On this occasion, the parties clearly expressed their desire to encompass community interests throughout the study by creating an advisory committee that is representative of the area.

#### Role and mandate of the advisory committee

The advisory committee will provide advice to the steering committee, and is mandated to:

- encourage ongoing discussion with local and regional stakeholders;
- establish constructive collaboration regarding all information pertinent to the study on the creation of a marine protected area;
- ensure that the concerns and interests of the Îles-de-la-Madeleine community are addressed.

#### Objectives

- Regularly inform the community throughout the different steps in the study;
- Gather comments from the various stakeholders;
- Encourage exchange of information and data relevant to the study;
- Work as a team to identify possibilities and limitations pertaining to the creation of a marine protected area in Îles-de-la-Madeleine.

#### Membership and representativeness

The advisory committee is composed of 11 members representing the different sectors in Îles-de-la-Madeleine. Their participation is voluntary. They relay information to their own organization and, if possible, other agencies from the same sector.

### Themes

Members of the advisory committee will be regularly informed of the study's progress. They will provide study content advice to the steering committee, especially on the following themes:

- Ecological, economic, social and cultural characterization of the study area;
- Portrait of natural resources and their potential for development;
- A hierarchy of conservation objectives to implement in a marine protected area;
- Identifying and describing sectors of interest for the conservation of marine biodiversity and cultural resources;
- Assessing opportunities for development, education and the enjoyment of the marine environment as well as challenges to the establishment of a marine protected area;
- Economic analysis of territorial conservation issues.
